•MTA and PLTP engage in extensive coordination with Montgomery County Schools to address key issues including:


- Specific design plans




Rosemary Hills Elementary School & Talbot Ave. Bridge

Construction Safety Measures

Retaining wall or fencing will be in place at all times to restrict pedestrian access to construction sites
Purple Line Transit Constructors will utilize as much of the existing school wall as much as possible to separate the construction workers and students/public
All Montgomery County safety and security requirements for contractors on school property will be followed






Wall Construction – Fall 2018








Bridge demolition – Summer 2019








New Bridge Construction Summer 2019 – 2020








New Talbot Ave. Ramp

New Talbot Ave. Bridge – Safer & More Accessible

- New bridge significantly improves safety and access for Rosemary Hills students and parents as well the community
- Existing bridge:
 - Width of roadway is only 18 feet
 - Provides only a single lane for both directions of traffic
 - No dedicated passage for pedestrians
 - Equipped with a low, irregularly-constructed wooden hand railing
- New bridge:
 - Width ranges from 45 to 55 feet
 - Provides two traffic lanes
 - Offers broad sidewalk ranging from 13 to 22 feet wide
 - Equipped with a high, clear safety barrier





Lyttonsville Place Bridge Closure

- Bridge is scheduled to close on or about June 18, 2018
- Closure will last no longer than 6 months
- Signage will be posted prior to closure for public
- awareness
- Closure approach provides a safer environment for drivers, pedestrians, and workers
- Temporary alternate routes are being provided to the community during the closure





Official Lyttonsville Place Bridge Detour


Lyttonsville Rd. to Brookville Rd.

Continue on Lyttonsville Rd. Lyttonsville Rd. merges into Grubb Rd. Right turn on East-West Highway Right turn on Jones Mill Rd. Jones Mill Rd. merges into Stoneybrook Dr. Right turn onto Capital View Ave. Capital View Ave. merges into Seminary Rd.

Right turn on Brookville Rd.

Brookville Rd. to Lyttonsville Rd.

Continue on Brookville Rd. Right turn on Seminary Rd. Right turn on Georgia Ave. Bear right onto 16th St. Right turn on East-West Hwy Right turn on Grubb Rd. Right on Lyttonsville Rd.


Role of the CATs

CATs are intended to:

- Promote two-way information sharing between the Purple Line team and the community
- Offer a forum for residents and other community stakeholders to engage in opendialogue with the Purple Line team
- Serve as an organized, results-oriented vehicle for identifying and addressing area-specific, construction-related issues and concerns related to Purple Line construction
- Provide accountability for follow-up actions agreed upon by the Purple Line team and the community













How Did We Get Here?

- CAT participant groups were identified within 1/3 mile of project alignment
- Chiefly composed of local resident and business groups, some at-large groups also represented
- Each participant group designated one primary representative and one alternate
- Terms "CAT representatives" and "CAT members" are used interchangeably
